



HomeAdvantage iPad Official Rules

NO PURCHASE NECESSARY TO WIN

All entries not accompanied by orders (establishing accounts or services) are treated the same as entries accompanied by orders. A purchase will not increase your chances of winning.

HOW TO ENTER: The sweepstakes begins on April 15, 2019. You will be entered into the sweepstakes upon registration into the HomeAdvantage Program through SAFE Credit Union's website. Limited to one (1) entry per individual. Alternate entries must be mailed on a plain 3.5" x 5" postcard.
